I understand that participation in these activities involves inherent risks, including but not limited to: indoor and outdoor activities around and near the Hopewell Tennis and Swim Center grounds, hikes and outdoor walks with potential exposure to mosquitos, bees, ticks, poison ivy, slippery and jagged surfaces, hot sun, and rain, swimming and water-related activities, which may involve serious or grievous injuries, including bodily harm, property damage, and/or death. I acknowledge that Firefly Clubs and the Hopewell Tennis and Swim Center reserve the right to update their policies and guidelines at management's discretion. I acknowledge and agree to the following terms:

Responsibility for Preparedness: I will ensure that CHILD is appropriately attired and equipped with insect repellent and sunscreen, which I will provide. I permit staff to assist in applying these items if needed. Medical Authorization: In the event of illness, injury, or accident, I authorize Firefly staff and/or Hopewell Tennis and Swim Center employees to act on my behalf to approve medical treatment and sign any necessary medical release forms. I agree to pay any medical or transportation expenses incurred. Behavior and Property Damage: I understand that inappropriate, disrespectful, or dangerous behavior may result in CHILD's dismissal from activities without a refund. I agree to cover costs for any property damage caused by CHILD's actions. Assumption of Risk: I acknowledge the risks associated with these activities, including but not limited to injury, illness, and death. I voluntarily assume these risks on behalf of CHILD. Waiver and Release: I waive, release, and discharge Firefly Clubs and the Hopewell Tennis and Swim Center, including their trustees, officers, employees, agents, volunteers, and affiliates, from any and all liability arising from CHILD's participation in activities, whether caused by negligence or otherwise. Indemnity: I agree to indemnify, hold harmless, and promise not to sue Firefly Clubs or the Hopewell Tennis and Swim Center for any claims related to CHILD's participation. Photographic Consent: I permit the use of CHILD's photo, video, or likeness for legitimate purposes by the activity organizers. Comprehensive Agreement: This document constitutes the entire agreement and supersedes prior written or oral agreements. It remains in effect beyond the conclusion of activities unless amended in writing by all parties.
